NOTE: Related Areas are Statistics, Risk Management and Insurance, Finance, or another subject appropriate for Actuarial Science.
- 1 year of college teaching or similar corporate training experience.
- Passed three preliminary actuarial professional exams.
- Evidence of quality teaching.

**Preferred Qualifications:**

- 3+ years of college teaching or similar corporate training experience
- Professional credentials such as the Associate or the Fellow of the Society of Actuaries, etc.
- Experience in course development.
